- GOAL 2** Improve cultural awareness and culturally appropriate supports for Native American students in project districts.
- GOAL 3** Improve access to culturally relevant and appropriate teaching, learning, and reading materials in all project districts.
- GOAL 4** Decrease double digit deficits in reading and math between Native American students and their same-grade peers to reflect the district average by the end of the five years.
- GOAL 5** Develop a sustainable program that serves the needs of our NA students
